The Bahá'í Council newsletter "CommuNIqué" has over time gone from 8 pages six times a year to four pages twice a year, a reduction of almost 85% in amount of content, and the quality, timeliness, and usefulness of what content there in has shown a significant decline. The Council's electronic list bahai-ni is good for announcing events but is not a communications medium of depth or substance when it comes to reporting events, sharing learning and insights, or otherwise encouraging the Friends, and of course does not carry photographs. Convention feels there is a great need for the Friends to receive these things: as things stand there is ignorance, discouragement, and a feeling of being cut off from, and not being a part of, the wider Bahá'í community even of Northern Ireland and of little real connection with the institutions.	The National Assembly appreciates the challenge that the Council for Northern Ireland is experiencing in producing a regular newsletter at this time, which is an important role of the Council. This Recommendation has been shared with the Council and it has been asked to explore realistic steps forward to overcome this challenge, with the assistance of the National Assembly as necessary.

These comments are noted by the National Assembly. Perhaps it would be helpful to make a distinction between jargon and the language that is being used by the Universal House of Justice to guide the community forward with a common understanding. In light of this, individuals are encouraged to better strive to understand the terms we are encouraged to use through study of the guidance and its application in our service.
